

INTERNATIONAL STUDENTS REQUEST FOR TRAVEL SIGNATURE

If you are leaving the U.S. and plan to return as an enrolled student at TMCC, you must travel with the following documents:

1. A valid I-20, issued by TMCC
2. A valid F1 visa stamp in your passport
3. A passport that will not expire for at least 6 months
4. A signature on page 3 of your I-20

To receive the signature, please complete this form and attach it to your I-20. The I-20 will be signed and ready for pick up within one – two business days.

PLEASE NOTE: If you plan to leave TMCC and return to the US to go to UNR, UNLV, or another school, you MUST have the I-20 from the new school to re-enter the U.S.; you cannot re-enter with a TMCC I-20 unless you will enroll at TMCC.

INTERNATIONAL TRAVEL CHECKLIST

You should **carry these documents** with you in your wallet or carry-on bag **when you return to the USA**. Normally you just show your passport and I-20, but having these documents can help you be prepared, if the officer has more questions about your study at TMCC.

- Current I-20 signed by Clare, Cyndi, or Donna Ballard in Admissions**
(Request one week prior to traveling, after you have registered for classes and paid your medical insurance.)
- I-94 card** (Small white card stapled in your passport. You will turn it in when you leave the USA, and get a new one when you return.)
- Current and valid F-1 visa** (located in your passport)
- Transcript** (unofficial – In WebReg, click ACCEPT button at top left, then the TRANSCRIPTS button and print your transcript.)
- TMCC Student I.D. Card**
- Medical Insurance card** (optional)
- Business cards of Clare (775-674-7627) or Cyndi (775-673-7062)**
- If not enrolled in 12 credits at TMCC, proof of approval for less than full-time enrollment.**

VISA or PASSPORT RENEWAL:

If you need to renew your passport or F-1 visa before returning to the U.S., please schedule extra time for this. After you return, **bring your new documents to Clare in RDMT 114B** to be copied for your file. We must **always** have a copy of your current documents.

MOVING:

Remember to **notify Clare in RDMT 114B within 10 days of moving**. We also need to know if you change your phone number, email address or mailing address.
