Following review of the progress report for the Truckee Meadows Community College veterinary technology program, the AVMA Committee on Veterinary Technician Education and Activities (CVTEA) continued the program on Full accreditation.

After consideration of the documentation provided, the Committee has determined that continued reporting is required on the following deficiencies (see chart(s) below):

The next report is due spring 2024 (April 15, 2024). Reminders will be sent out approximately 2 months prior to the due date. However, all programs are required to submit a progress report due Fall 2023 (September 15, 2023) to address rabies policy and mitigation processes through a reporting instrument in the Armature software management system. Absence of documented compliance by the September 1, 2023, deadline may lead to a change in accreditation status. The next accreditation site visit is scheduled for 2027.

If there are any changes that impact critical or major deficiencies that the CVTEA previously determined do not require continued reporting, the program must report this change.
