catalog to facilitate transfer to UNR.

The Logistics Management program shifted CH 203 from a required general education course to a recommended

general education course in the Fine Arts/Humanities/Social Science.

DA 111 made some edits to correct typos for the next catalog.

ACC 222, BUS 111, BUS 112, BUS 117, and BUS 225 were supposed to have been listed as transferrable. Just

waiting on CCN approval to move forward.
